 - Custodians : A certified true copy of the certificate of incorporation, notarization by a notary public of the country issuing such documentation for a period of no longer than 12 months prior to the respective Exercise Date, including a letter of custodian appointment and a certified true copy of the documents specified in Clauses 1) or 2) of the authorized director(s) (as the case may be)

If the Warrant Holder fails to submit the aforementioned supporting documents when exercising the Warrants, the Company reserves the right to deem that such Warrant Holder does not intend to exercise the rights under the Warrants on the relevant exercise date. Nevertheless, the Company
